FIGHT BACK UPDATES

- <u>Crime Prevention Committee</u> If you have a street light petition, please return it to Lisa Huggins-Hubbard of Neighborhood Services as soon as possible.
- **Community Enhancement** Bel Air Neighborhood street sign toppers will be installed soon on the streets leading into our neighborhood (Indian School Road, 15th Avenue, and 19th Avenue). Due to the new larger street signs on Indian School Road, the Bel Air signs will be installed on extension poles below the street signs. Plans are also underway for Bel Air Neighborhood alley fences. The locations where the twelve fences will be installed are: (1) along the south side of the Grand Canal at 18th Avenue (2) along the south side of the Grand Canal at 17th Avenue (3) at the alley entrance located between Glenrosa Ave. and Heatherbrae Dr. off 19th Ave. (4 & 5) at the alley entrances on both sides of 18th Ave. located between Glenrosa Ave. and Heatherbrae Dr. (6) at the alley entrance located between Glenrosa Ave. and Heatherbrae Dr. off of 17th Ave. (7) at the alley entrance located south of Heatherbrae Dr. off 19th Ave. (8 & 9) at the alley entrances on both sides of 18th Ave. located just south of Heatherbrae Dr. on the west and between Heatherbrae Dr. and MacKenzie Dr. on the east (10) at the alley entrance located between Heatherbrae Dr.and MacKenzie Dr. off of 17th Ave. (11) at the south alley entrance between 15th Ave. and 15th Dr. off Glendale Ave. (12) at the alley entrance off 15th Ave. just north of 16th Dr.

May General Meeting/Elections - Roshelle

Two potential dates for the May General Meeting/ Elections were discussed. The dates are: May 16th at 9am (Continental Breakfast style) and May 12th at 6:30pm (Dinner/My Mother's lasagna). Roshelle will check with the American Lutheran Church to see which of these dates the gym might be available. Roshelle or Lisa may invite our councilman to be the speaker for the evening. The topic for the evening might be the economic recovery. The Police Department might be asked to have an informational table at the event. Roshelle may contact Crisis Nursery to see if they will have a face painting booth at the event. Phone Tree giveaways will also be part of the event.

Fight Back – Lisa Hubbard

Street light petitions were distributed at the February General Meeting. These need to be returned to Lisa with Neighborhood Services. A notice to this effect needs to be placed in the May/June newsletter. A second safety audit needs to be organized. Virginia will work with Lisa Hubbard on the second safety audit.

There has been a lot of planning for the Bel Air Neighborhood Yard Sale. Lisa has ordered many neighborhood yard sale signs, a table with a very nice table cover. A 10'x10' pop up tent was ordered with a color Bel Air logo on it. The logo is green. Some of these items can also be used for a Bel Air Neighborhood Association booth at various future events (such as: 7th Ave/Melrose events).

Street sign toppers have been ordered and are coming. Work is still progressing for gates on specific alley entrances in Bel Air. Various bids have been received and are being reviewed. Lisa brought a map to this meeting depicting the locations of the proposed gates. Adult probation will be coming by to clean alleys and easements.

The new owner of the apartments at 1517 W. Indian School Rd. would like to be involved in the surrounding community. The apartments are now gated and remodeled.

A licensed contractor must be hired to paint missing/ faded house numbers on street curbs in Bel Air. Erik Carpenter is currently the one licensed curb painter. The estimate he gave for painting all of the house numbers in Bel Air is \$3,000. This expense can be paid for with Fight Back funds. Virginia made a motion for Erik Carpenter to be hired for this project. Don seconded the motion. The motion passed.

Traffic Committee – Roshelle

The proposed speed hump for Glenrosa Ave. is now being opposed due to the exact location where the speed hump would have had to be installed due to various distance guidelines/restrictions. The exact location would have seriously interfered with a property owner's driveway. The proposed speed hump on 15th Drive is also being opposed.

Crime Committee – Virginia

The Bel Air Neighborhood Books are complete. The will be 3"x5" 80-sheet notebooks with safety related info included. The cost to order 150 of these books is \$1 each. Virginia would like to distribute them at general meetings. It was decided that 500 will be ordered to possibly reduce the cost per book while acquiring enough books for Bel Air residents/property owners and distribution at future events.

Community Reports – Roshelle

Roshelle attended a meeting titled, "Forward Thinking, Surviving Hard Times."

Community Reports – Charles

Charles attended Councilman Simplot's Breakfast in March. Bob Khan from the Phoenix Fire Department was the guest speaker. The Phoenix Fire Department is the 6th largest in the country. It handles 15,000 calls a year for our area. A commander of the uniformed non-sworn officers that patrol the light rail also spoke at the meeting.

Community Reports – Lisa

Lisa attended a recent crime summit of approximately 35 people from the community. Many new ideas come from these crime summits.

Board Elections – Roshelle

Jeannie Garcia has resigned from the Bel Air Neighborhood Association Board.
