# In Attendance:

Approval of the March 3, 2005 and BelAir Board Meeting Minutes were tabled under the next Board Meeting.

#### **Treasurer's Report:**

The Treasurer's Report for the Association's General Fund, Grant #50 and Grant #62 as of 3/31/05 was provided and approved.

**Grant Projects Status Update:** Grant #50 – still in process of obtaining approval from property owners to install Block Watch signs with installation to be complete by 6/30/05; monthly Block Watch meetings and regular patrols will continue; and the newsletter has run out of funding from the Grant and will be funded from the general fund.

Grant #62 – the two dusk-todawn lights have been installed and electricity paid for 3 years; additional privacy slats were installed on the fence on 3/19/05. Another service day will to install the remaining slats will be held on April 30<sup>th</sup>, 7:30-10:30AM at the park.

#### Newsletter:

The May and June newsletter will be combined into one newsletter due to the fact that the grant funding has been exhausted and the printing costs are now being funded from the general fund.

# **Old Business:**

All board members are requested to submit volunteer hours to the Secretary for recording. Assignments for the General Meeting on April 14<sup>th</sup> were discussed. Also, the terms of all board members were reviewed to determine who would be eligible for reelection. The community service day on March 19<sup>th</sup> was discussed as well as the neighborhood rummage sale on April 2<sup>nd</sup>. A total of \$160.25 in proceeds was generated from the sale. Thank you to everyone that donated and volunteered hours to make the sale a success.

#### New Business:

The board is obtaining rental prices for a storage locker for the Association materials. The Association has several items that need a safe, secure home. The next neighborhood clean up on May 5<sup>th</sup> was discussed.

The meeting was adjourned at 8:00 pm.

In Partmahie With Phoenix Police Department

by Hugh Lander All stats come from the Phoenix Police Crime Statistics website at <u>www.faxnet1.org</u>. Our grid is "BH25". "BH25" covers 15<sup>th</sup> Ave. to 19<sup>th</sup> Ave., Indian School up to Campbell north of the canal, which means it covers all of BelAir and the area just north of the canal.

We had an April Block Watch meeting, even with just three of us!!. We're moving forward with the BelAir Phone Tree, which we are going to try to "activate" in May. Our next meeting is still to be scheduled for May or June as we are working to find a new "boss" for Block Watch here in BelAir. Look for the newsletter or on the BelAir website for more info. There were no crimes

reported to me last month,

although I did note that someone had vandalized one of the vehicle gates along the canal and had tagged some street signs. I reported the tagging and the signs were cleaned up the next week, and SRP has installed a new gate at the 15<sup>th</sup> Ave, end of the canal. Looking at the statistics for January and February combined, there was one violent crime, an assault (I think this occurred north of the canal); plus 13 burglaries, 9 thefts and 3 auto thefts for a total of 25 property crimes. This compares with a total of 33 property crimes just for November and December - a good decrease.

WHAT CAN YOU DO TO STOP IDENTITY THEFT?



One solution is to eliminate the "pre-approved" credit card applications that show up in your mail.

To prohibit the use of your credit information from being used for offers of credit you did not initiate, you must notify the credit reporting agencies either by telephone or in writing. Notification by telephone prohibits them from using your information to initiate offers of credit without your consent for two years.
