Lawyer's Library by John D. Shaw Attorney at Law

In this column I intend to address, in general terms, a few questions of legal terminology that frequently arise. As a first installment, I will define and discuss briefly some estate planning terms that more often than not require explanation.

WILL: A document stating how you want your property distributed upon your death and whom you would want to care for your minor children. Wills generally do not apply to the distribution of life insurance proceeds and other assets of the kind that allow you to designate a beneficiary.

LIVING WILL: A document carrying your written intention not to be kept alive by artificial means when there is not a reasonable hope of recovery.

PROBATE: A court procedure originally established to carry out terms of a will. Under current law, most wills do not require a probate procedure.

TRUST: An entity in document form, created by law, to hold title to assets in the name of a Trustee appointed by the Trustor, that is, the creator of the trust. Trusts are used in some instances where it is deemed desirable to reduce tax liability; to avoid probate procedures; to protect assets from creditors; or to control the manner in which property is

distributed after death of the trustor.

LIVING TRUST: A trust set up during the lifetime of the Trustor.

TESTAMENTARY TRUST: A trust contained within a will and going into effect at the person's (Trustor's) death.

POWER OF ATTORNEY: A legal document giving another person the authority to act legally on your behalf. It may be a specific authorization; for example, sale of a piece of property; or it may be general, empowering the person to do all acts on your behalf. power of attorney automatically revoked upon establishment of the mental incapacity or death of the person who ceded it originally.

DURABLE POWER OF ATTORNEY: A document which would be valid even if the person granting the power were mentally incapacitated. It would be revoked upon death of that person.

The above definitions are very general, intending to help you begin to understand these terms when you first encounter them. If you have further questions, ask an attorney.
