



## Minutes of Association General Meeting

The January 8, 2000 Board Meeting was held in the Fireside Room at Martin Luther School, 1830 W. Glenrosa. The meeting was called to order at 9:08a.m.

Minutes from the November meeting were approved as read. The financial report was accepted as submitted.

**General Meeting** - The committee updated the Board on the General Meeting that to be held on January 20, 2000. They are keeping this meeting as a fun approach to get involved. Anna stated that she would have the police appreciation book there again to continue to fill the blank pages.

**301 Grant 2000** - The committee for the grant continues to meet to discuss possible ideas for the new grant. The committee is going to solicit ideas at the General Meeting.

**Newsletter** - There was some discussion about the delay of the newsletter this month. It was determined due to the holidays; the process got slowed down. The print shop we use was closed and they do not rush our order. In return for that, they do not charge the Association as much for printing.

**Spring Neighborhood Clean Up** - The spring cleanup is scheduled for

February 19, 2000 at 7am. We will be meeting in front of Jeannie Garcia's house. Look for an article in this newsletter for more information.

**301 Grant 1999** - The committee has located the poles that the lights will be located on. Betty Dales and Anna Blevins are now going to get the numbers off the poles and submit the information to APS.

**Neighborhoods That Work Award** - The deadline for the application for this award is February 25, 2000. Laurel Moran volunteered to write the grant for the Association this year. Sharon Barger offered her assistance. This is the award that our neighborhood was the District 4 winner last year.

**Announcements** - Anna Blevins announced that the facility that was going to be located on the 7th Avenue/Osborn area was denied a zoning permit. The facility was to be a transition area from prison back to society. They are appealing the decision. Pastor Charles Wilfong stated that the police did a sweep of the Westwood Neighborhood on December 17 and 18. The high school kids had a meal planned for the homeless on the 19th and no one came. They did take the food to the Andrea House. Fliers were passed out by the Fire Department and Pastor Wilfong in the Westwood Neighborhood regarding not shooting guns on New Year's Eve. Pastor Wilfong also took some fliers door to door in our neighborhood.

# Census 2000



## We all Count!


The national count begins in March with a mailing of a questionnaire to households throughout Phoenix and the United States. Completing the form and returning it before the April 1 deadline is important. Make sure everyone in your household is counted, including children, undocumented workers and winter visitors. No one will see your responses. It is illegal for the Census Bureau to share information with INS or police.

In just five years, Phoenix has grown from 984,000 to 1.15 million, straining city resources. By counting all residents, the city will be assured of getting its share of all federal and state funds that are distributed to communities based on their population. For every resident counted, the City of Phoenix will receive \$4,150.20 over the next ten years. That money pays for police and fire protection, streets, parks and recreation programs.

For every person missed in the county, Phoenix will lose \$415.00. In the last general census in 1990, Arizona was the fourth most undercounted state in the country, and lost about \$35 million because of the undercount.

Enumerators and office workers are needed for Census 2000. Jobs paying from \$12 to \$14 an hour will be available March-July. If you or someone you know is interested, call 602/379-4131 or (toll free) 1/888/325-7733.



The Arizona Revised Statutes say, you must stop, no matter which way you're headed and no matter how wide the road, for any school bus that is stopped with lights flashing and stop sign extended.

You do not have to stop if you are in oncoming traffic, that is going in the direction opposite of the bus, and the road is divided by a physical barrier, "such as a fence, curbing or separation of the pavement" according to the Arizona Drivers' Manual. Pavement striping does not count as a physical barrier.

So, for instance, if you're southbound on 7th Street way over in the outside lane and there is a school bus stopped way over in the outside northbound lane, lights flashing, etc., you had better stop.

The speed limit in a school zone is 15 mph. When school is in session, there are three roll-out signs, two at either end of the school zone announcing the speed limit and one in the crosswalk. What's the speed limit after you pass the crosswalk, but are still in the school zone? Answer: Once the rear bumper of the car has passed the crosswalk sign, you may accelerate back to the posted speed for the area.

One last thing about school zones, the signs say "no passing". If the car next to you is going 5 mph, then the new posted speed limit is 5 mph, because you cannot overtake that car in a school zone

under any circumstances. And if there's a car stopped in the turn lane waiting to pull into the school parking lot, you may not simply cruise on past, no matter how safe it seems. No Passing.

Board of Adjustment Clarification

As a member of the Phoenix Board of Adjustment I feel I should explain a ruling the board made on January 6. The decision I am referring to was a determination of whether the provisions of the "Phoenix Zoning Ordinance" allowed for a private community corrections center located at 3333 North 7th Avenue. The owners of the proposed facility called it a "recovery home". The property is zoned C1. All C1 zoning allows recovery homes by matter of right. It was our task to determine if the facility was indeed a recovery home. We were not deciding "if a prison could be located in a neighborhood area" as some media coverage indicated. The board upheld the decision of the zoning administrator. We decided that this facility was more like a private prison than a recovery home. Private prisons are not allowed on C1 properties. This case may be appealed to Maricopa County Superior Court. This decision relates not only to the above mentioned property, but all C1 properties.
