Minutes from the June meeting were approved with one clarification. The Treasurer's reports for the General Fund and the 301 Grant were approved as submitted. We have entered the new year for the 2000-01 301 Grant.

301 Grant 2000 - The check has been picked up from the city and A timeline for the deposited. completion of the projects will be done at the next Board meeting. Committees will be formed in August to get the projects underway.

July 18th General Meeting - The committee updated the Board on the plans for the General Meeting. They reported that basically everything is ready to go.

G.A.I.N./Fall Festival - The committee has met two times. They are asking the neighbors for ideas for music and entertainment. If anyone has ideas for this, please call the hotline.

New Neighbor Welcome Mats -The Board unanimously approved a motion to spend up to \$20 of the General Fund to purchase welcome mats for the new neighbors that attend general Welcoming the new meetings. neighbors is always a part of the meetings and the mats would be a "thank you" for attending the Association meetings. They will be purchased and part of the July meeting.

Stepping Stones - The committee is making a set of the stepping stones for display at the General Meeting. They will see what type of interest is in this project. If there is interest, the project will be pursued.

New Board Member - The Board will vote on a new board member at the August Board meeting to fill the vacancy of Laurel Moran's The new member would seat. begin in September.

Liquor License Application -There is a pending liquor license application for a business on 19th Avenue in our neighborhood. The Board will write a letter protesting the approval of this license as it was felt there were enough options in the near vicinity.

Other - Pastor Wilfong reported that there is mention that a Food City grocery store will be opening in the old PriceRite Building. From what he heard, this is to open in August. Construction is underway at the park being built in the Westwood neighborhood across 19th Avenue.

Meeting was adjourned at 10:21 am. The next Board Meeting will be on August 12, 2000. Please check with any Board member as to location.




On October 21 we will present our 5th annual Good Neighbor Award to a Bel Air Neighborhood resident.

blight (blite), noun definition: In a city or community, an existing area in which the property has deteriorated below acceptable standards.

The City of Phoenix enforces blightful condition ordinances to those home in neighborhoods that do not comply. Your Phoenix Neighborhood Services Department at (602)262-7844 will take your complaint(s) of an offending homeowner and send an inspector out to assess the property This is done in auestion. confidentially so your neighbor has no knowledge of your call. You must give them the address and the violations.

Blightful conditions are:

- * broken windows
- * rotting wood (fences, carports)
- * peeling paint (houses, sheds)
- * roof in bad need of repair
- * overgrown grass/vegetation
- * parking cars on lawns
- * cars on blocks in driveways
 - storage of furniture, appliances in visual view of the street
- * swimming pools polluted, unkempt and bringing infestation of mosquitos or stench

Call the City of Phoenix at (602)262-7844 and have notices sent to violators to comply within 30 days or face substantial fines.
