#### Board Meeting Minutes

Date: February 1, 2010

**Location:** Gym @ American Evangelical Lutheran Church (AELC), 1830 W Glenrosa The meeting was called to order by Steven Hofmann, who was asked to stand in for President Roshelle Johnson, at 7:05PM..

In Attendance: Members: Carolyn McBane, Jeanne Greene, Steven Hofmann, Carrie Frazer, Gary Hall, Donald Hilton, Charles Wilfong, Marney Redmond, and Wayne Harman. There were 5 residents of BelAir in attendance in addition to the board members.

**Pros/Cons of Special Meeting:** It was agreed that factual information was presented, there was a good turnout with a diversity of input; resource persons from entities such as SRP and City of Phoenix showed support for our neighborhood; newcomers to the neighborhood attended.

**Treasurer's Report:** Don Hilton presented the Treasurer's Report. The general fund had a beginning balance at December 31 of \$888.59. Check #176 in the amount of \$95.03 was written on January 29 for Adopt-A-Family expenses and a deposit was made on January 29 in the amount of \$21.00 from two ads in the newsletter. The ending balance was \$814.26 on February 1, 2010.

Minutes: The minutes for the November 2009 board meeting were reviewed. Don moved that they be approved, Marney seconded, and the minutes were approved. The January 2010 board meeting minutes were reviewed. Don said that the beginning balance as of October 31 for the Block Watch grant should be changed to \$2,304.98 and the ending balance as of December 31 should be changed to \$2,191.43. That correction was made and Wayne moved the minutes be approved as corrected. Steven seconded and the motion carried.

# Bel Air Neighborhood Special Meeting January 23, 2010 Minutes

Steven Hofmann opened meeting.

Discussion today:

Fight Back Issues

Gate Issues

ASU Facilitator- passed out cards for questions

Timekeeper – Jerry - 3 minute limit for speakers.

#### City of Phoenix – Lisa Huggins-Hubbard, Neighborhood Specialist, NSD

Presented history of Fight Back Program Overview of Survey with concerns and issues.

Committee was formed Sept. 2007 Fliers were sent to every "Resident Initiated Program Household".

Plan voted on Feb. 2008.

Stated that this was an "Open Process", Canal Project – Improvements along canal "Pedestrian Friendly".

Only a Visioning Project – No funding.

#### **Gates and Fences**

Initiated through Traffic and Crime Committee.

ASU School of Architectural Design is working on "Artistic Designs"

"No Mandate" by the City of Phoenix. Citizen Committee needs to Drive Process, if anything is developed.

There is funding for gates and fences. 8 locations "Proposed". Design needs to be looked at.

75% of residents need to approve abandonment for gates.

Different processes for Easements. Alleys, Gates and Fences.

Neighbors must decide.

Introduced

Phoenix Police Sergeant Gary Coffman. Dave Keifer from SRP.

## **Phoenix Police Sergeant Gary Coffman.**

Discussed Herion abuses – home on Heatherbrae.

17th Avenue home a real challenge. Drug Abuse.

Sergeant stated that he was offering his opinion only and that he would close his own alley. This would accomplish Access Control and Target Hardening.

A block wall is a Graffiti opportunity and offers seclusion for crime.

Drug trafficking does occur down alleys. CPTED. Crime Prevention through Environmental Design would require that gates do not obstruct the view down an alley.

#### **Carrie Frazer**

Presented arguments against gating the alleys. A written copy of her concerns was given to the Police, Phoenix, SRP and the Neighborhood Association Board Members. A copy is attached to these minutes. Many safety concerns were presented, especially noted was the danger to women who irrigate and would have to get out of their cars to open alley gates, sometimes in the middle of the night.

## **Phoenix Police Sergeant Gary Coffman.**

#### (Comment noted later in the meeting)

I am concerned with the issues raised by Carrie and her problems with irrigating and having to get out of her car at night to unlock gates.

This is a real concern for safety.

#### <u>Darlene Justus, President North</u> <u>Tempe Neighborhood Association</u> (Disclosure- Carrie Frazer's aunt)

Pointed out that fencing an area can sometimes create a haven for intruders rather than keeping them out. Case in point: The City of Tempe fenced a riparian region behind the Arizona Historical Society Museum to keep out homeless and vagrants. The fence acted as a barrier for law-abiding citizens preventing them access to the riparian area, while creating a haven for the wrong folks and even kept citizens from interfering with their camp. We have found that encouraging citizen access deters crime. Appropriate lighting improves security and encourages citizen use.

#### **Walter Scott, Comment and Question**

Good job Community Policing. Is there any reason to change alley and canal access?

#### **Phoenix Police Sergeant Gary**

#### Coffman.

"You are in a nice neighborhood." Canal limits access to your neighborhood. You have multiple challenges surrounding your neighborhood.

#### Walter Scott, Comment

"Need to balance enjoyment with needed safety".

# **Phoenix Police Sergeant Gary Coffman.**

Fencing Canal can do two things. Keep bad guys out of neighborhood and kids out of the canal.

#### Walter Scott, Comment

Alley and canal access are two different things.

Limited access to alley is a good thing.

# Phoenix Police Sergeant Gary Coffman.

The canal is a natural barrier. "If I were king, I would put a wrought iron fence along the canal".

#### **Walter Scott, Comment**

I want a walkway on the canal.

# **Phoenix Police Sergeant Gary Coffman.**

"If you just want to limit crime, you could become a gated community. However I am not a proponent of that". Bel Air's crime statistic data includes the area north of the canal, which is a "bad area". The statistics are not representative of Bel Air's low crime rate.

#### **Walter Scott, Question**

From a crime perspective, would we have less crime with no alley easement?

## **Phoenix Police Sergeant Gary Coffman.**

"Yes."

#### **Carrie Frazer**

There recently was a home burglary in a home without an alley easement.

#### **SRP Official**

When canals are lined SRP paves the road on the access side of the canal. Pedestrian bridges over the canal have been offered. However, citizens because of concerns that they would be connecting bad regions to their neighborhood have stopped them.

SRP will not light the canal.

If alley gates are put in they must provide you with a key to the lock. Access cannot be impeded. Water flow cannot be blocked.

#### Mark Day

There is a Break Ins and Buildings report.

History- there have been break ins from the alleys.

Maybe we could have done a better job communicating.

We have encouraged all to get involved. We have 5 participants.

There are sign up sheets at this meeting.

#### **Ken Jones**

Gates along the canal, not a good idea. Instead encourage activity.

Want more crime analysis, not opinions.

#### Mike Radtke

Circulated a petition to not obstruct canal. In early December had approximately 100 signatures. Now have 140 signatures. The Association has never acknowledged the survey. The survey was given to Steven Hofmann at this Special Meeting. What do we have to do to get the Board to take this issue off the table?

#### **Beverly Brown**

Realtor for 12 years.

Has irrigation from alley. Will not take irrigation. However will rake ditch. Planning to take out trees along ditch. There are bad elements using the alley. Resigned from the Board. Don't have the time. Losing "Quiet Enjoyment". Need Community Beautification.

#### Max Thompson-McCue

We are talking about controlling access to our community. You would have a key to locks. There is not a high volume of walkers in the alleys. Not talking about permanently closing the alleys.

#### **Tracy Spencer**

Very impressed with the community.

Need 75% agreement to block alleys and easements.

75% could be necessary to close access to the canal.

Proposed – 27 gates at \$500 per gate. Can we get attractive gates for \$500 each?

#### <u>City of Phoenix – Lisa Hubbard,</u> <u>Neighborhood Specialist, NSD</u>

\$7-900 each gate installed.

#### **Tracy Spencer**

Could the \$13,000 gate funding be reassignable to something else for the community?

#### <u>City of Phoenix – Lisa Hubbard,</u> <u>Neighborhood Specialist, NSD</u>

The funding is for Infrastructure funding. Lighting is a possibility. Want to get funds allocated as quickly as possible, while the funds are still available.

## City of Phoenix Supervisor, Annie M. Alvarado, Deputy Director, NSD

Money will stay. However need to build consensus within the neighborhood. The funds are for a CIP, Capital Improvement Project.

Everyone has a right to make his or her wishes heard.

#### **Neighbor Question**

Why are several alleys not proposed to have gates?

#### <u>City of Phoenix – Lisa Hubbard,</u> Neighborhood Specialist, NSD

North of 15th Drive and North of Glenrosa there is parking in the rear.

#### **Dick Bushouse**

Commented that neighbors need to call the police when you see someone who doesn't belong and you are concerned.

#### Estela Guerra

Locking gates to alley access will not prevent crime. 3 cars were stolen from the front of my house.

#### **Steven Hofmann**

There is human waste in the alleys from

people who do not belong in our neighborhood. Want to encourage more pride.

#### Susan Thompson-McCue

There is a 301 Block Grant for alley lights. There are sign up lists at this meeting. Please get involved.

#### Senator Jack Brown

I am a half time resident in the neighborhood. Encouraged all to be orderly, "We are all in one neighborhood." Be respectful, work together. The canal is a big ditch. I don't want to make it a short cut.

#### Nicholas Radtke

Our petition has 140 signatures representing approximately 90 households. We do not want the canal access blocked. The Board won't respond. There are approximately 300 households in the neighborhood with about 150 rentals. We have shown that this is not wanted. Why are we still discussing the canal?

#### **Board Member**

In the future when there is funding we will look at the canal. The Board is trying to get all of the facts. We are now concentrating on the alleys.

#### Nicholas Radtke

Must we abandon the alleys? Will the property be give to the homeowners? If gates are put up, individuals could lock them. There is a 3AM irrigation issue. Irrigation users need access.

#### **Don Hilton New Resident**

Joined the Board.

Worked in Mesa with canal paving and lighting. Concerned with crime in the neighborhood. When law officers are laid off we will have more crime.

#### **Tom Greenwalt**

I am not on the committee. I am involved in the community. Don't shortcut us.

#### Max Thompson-McCue

Need to prioritize time on alley issues.

Re: Proposed Alley/Easement Gates in Bel Air

#### A Concept I Like

The idea of beautifying certain areas in our neighborhood with the use of artwork and landscaping is very appealing.

#### My Concerns

- 1. **Installing gates will provide a safer haven for homeless** and criminals and thus attract more of them due to the resulting increased isolation. Other cities have experienced this (ie: behind the Arizona Historical Museum in Tempe).
- 2. **Multiple concealment areas would be created** on alleyways undermining visibility into the alleys from adjacent streets, and create concealment areas that create easy access to property. This is dangerous for residents and police force alike. (See Bel Air Neighborhood Safety Audit Report dated 11-14-2008)
- 3. Residents would be more exposed while irrigating, especially in the middle of the night. Instead of being able to drive down the alley north of Heatherbrae Dr. in our locked cars to check on the water or access our (irrigation) gates, we would have to stop to open and close gates at easily predictable locations where criminals could be waiting. (Many of these residents are women.)
- 4. **Fast exits from the alleys will be eliminated.** Even an unlocked gate would most likely be latched.
- 5. Latches may pose too much of a challenge, especially for vision impaired residents. Night conditions will also add to the challenges for all residents.
- 6. The gates will give the wrong impression to some residents. They will interpret them as a green light to move their back fences into the middle of the alley. This will seriously affect the safety of residents who need to take care of the water in the ditches in these alleys.
- 7. Our potentially historic neighborhood irrigation system may be adversely affected by some of these proposed improvements.
  - 8. Placing gates on the alleys/easements will enable anyone to easily lock us out of the alleys/easements where we are responsible for our water.
  - 9. **Residents' water rights would be violated** the alleys both directly north and south of Heatherbrae Drive contain open irrigation ditches.

A.R.S. 45-112-A8 states: A person is guilty of a class 2 misdemeanor who: Places or maintains an obstruction interfering with the use of works, or prevents convenient access thereto, when an appropriator of water has the lawful right of way for the storage, diversion or carriage of such water.

In response to the discussion surrounding the proposed gates at both the Grand Canal and the alleys both with and without irrigation ditches in the neighborhood and the information and discussion presented at the January 23 Special Meeting, two amendments to the Fight Back Action Plan were presented and voted on as follows:

Marney - "I would like to make a motion to amend the Fight Back Action Plan as follows. Regarding planned improvements along the canal, I move that we replace the reference to gates/fences along the canal with this wording instead, 'infrastructure improvements along the canal of a non-restrictive/non-obstructive nature.'"

Discussion followed, Steve passed around a picture of an archway-type opening that might be one result from accepting the proposed wording. Gary seconded the above motion and it was approved.

Marney - "I would like to make a motion to amend the Fight Back Action Plan as follows. Regarding planned improvements along the alleys and irrigation ditches, I move that we investigate each alley or ditch on a case by case basis instead of making a decision that would apply equally to all alleys or ditches."

Discussion followed on this motion, it was seconded and the motion carried.

Charles Wilfong announced that one of the parks being looked at to be closed by the City of Phoenix is the Kids' Street Park in the Westwood neighborhood. He asked that those in attendance write a letter to Donna Neal of NAILEM and/or to the City officials asking them not to close this park.
